- The ACII candidates will be required to acquire a qualification of ACII's 60 credit hours within the period of training i.e. two years. Thereafter upon acquiring ACII's diploma Level and advanced diploma Level they will be elevated / promoted as per terms and conditions of the contract.
- The FLMI seeker candidates will be required to acquire a qualification of ALMI Level (5 papers) within the period of training i.e. two years. Thereafter upon acquiring qualification of FLMI Level, they will be elevated / promoted as per terms and conditions of the contract.
- If trainee has acquired exemptions in credit hours or papers in ACCII or FLMI based on previous qualifications, it is mandatory for the trainee to attempt and successfully pass at least two papers of ACII or FLMI after joining the organization.
